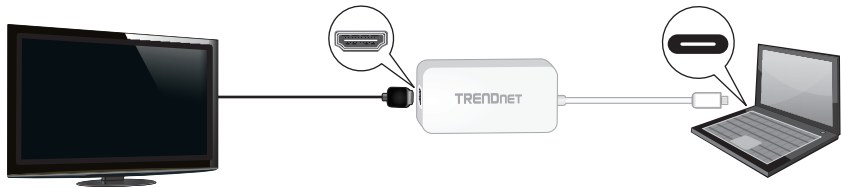

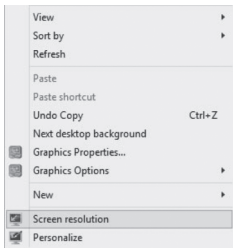
Note: Alternate Mode is required to use this adapter. Plugging the adapter into a USB-C Hub without Alternate Mode may result in no signal.

Duplicate Mode: Duplicates the same desktop content on two displays.

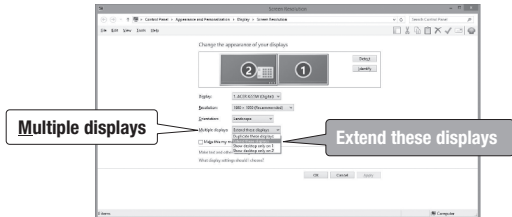
Extend Mode: Extends your computer's desktop to an additional display.

For Windows

1. Make sure each display is connected and on.
2. On the PC/laptop connected to the TUC-HDMI, right click on your desktop and select "**Screen resolution**".



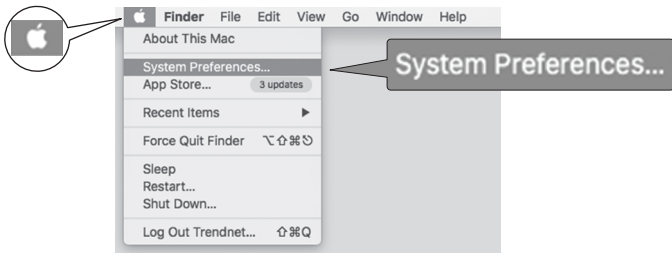
3. Click on the “**Multiple displays**” dropdown and select either “Duplicate these displays” (**Duplicate Mode**) or “Extend these displays” (**Extend Mode**).
4. Click “**Ok**” to confirm changes.



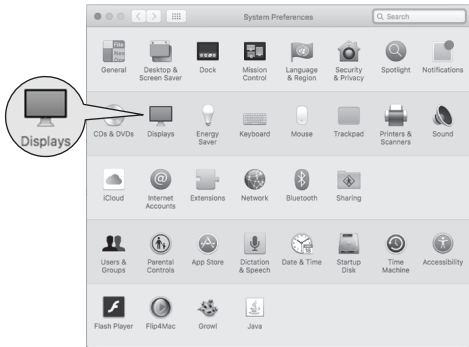
5. Windows will prompt you save the settings. Click “**Keep Changes**”.

For Mac

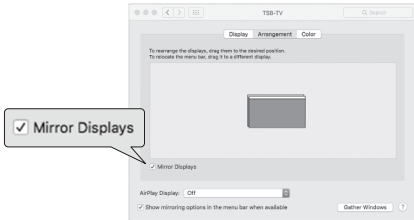
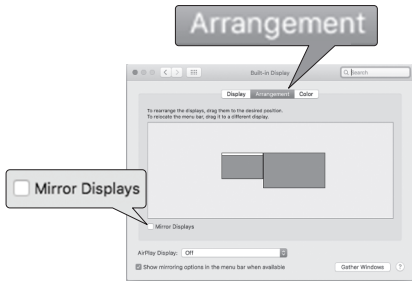
1. Make sure each display is connected and on.
