The FMCI-AF1/BF1 media converters convert 10/100Mbps Fast Ethernet from an electrical signal to an optical signal and back to an electrical signal. The electrical connection uses an RJ45 data connector.

Depending on the specific model in use, the optical connector is either a ST or SC, 1 or 2 Fibers, multimode (MM) or singlemode (SM), and the unit operates on either AC/DC or DC only power.

The standard size units may be directly plugged into the Rack (Pelco Part US-RACK or EU-RACK) or operated as a standalone module. The small size units operate as standalone modules only.





# FIGURE 1 - FMCI-(A,B)F1(SM,MM)1ST SERIES STANDARD SIZE UNIT




# FIGURE 2 – FMCI-(A,B)F1(SM,MM)1ST SERIES STANDARD SIZE UNIT

# FIGURE 4 – FMCI-(A,B)F1(MM,SM)1STM SMALL SIZE UNIT




# FIGURE 5 - LED INDICATORS

#### **INSTALLATION CONSIDERATIONS**

The FMCI-(A,B)F1(MM,SM)1ST media converters are supplied as Standalone/Rack modules. The FMCI-(A,B)F1(MM,SM)1STM small size media converters are supplied as Standalone/Surface Mount modules. Units should be installed in dry locations protected from extremes of temperature and humidity.

#### CARD CAGE RACKS

**CAUTION:** Although the units are hot-swappable and may be installed without turning power off to the rack, the manufacturer recommends that the power supply be turned off and that the rack power supply is disconnected from any power source. Note: Remove electrical connector before installing in card cage rack.

 Make sure that the card is oriented right side up, and slide it into the card guides in the rack until the edge connector at the back of the card seats in the corresponding slot in the rack's connector panel.
 Seating may require thumb pressure on the top and bottom of the card's front panel.

CAUTION: Take care not to press on any of the LEDs.

2. Tighten the two thumb screws on the card until the front panel of the card is seated against the front of the rack.


WARNING: Unit is to be used with a Listed Class 2 power supply.

#### **IMPORTANT SAFEGUARDS:**

- A) Elevated Operating Ambient If installed in a closed or multiunit rack assembly, the operating ambient temperature of the rack environment may be greater than room ambient. Therefore, consideration should be given to installing the equipment in an environment compatible with the maximum ambient temperature (Tma) specified by the manufacturer.
- B) Reduced Air Flow Installation of the equipment in a rack should be such that the amount of air flow required for safe operation of the equipment is not compromised.



#### WARRANTY

Pelco will repair or replace, without charge, any merchandise proved defective in material or workmanship **for a period of one year** after the date of shipment.

Exceptions to this warranty are as noted below:

Pelco will warrant all replacement parts and repairs for 90 days from the date of Pelco shipment. All goods requiring warranty repair shall be sent freight prepaid to a Pelco designated location. Repairs made necessary by reason of misuse, alteration, normal wear, or accident are not covered under this warranty.

Pelco assumes no risk and shall be subject to no liability for damages or loss resulting from the specific use or application made of the Products. Pelco's liability for any claim, whether based on breach of contract, negligence, infringement of any rights of any party or product liability, relating to the Products shall not exceed the price paid by the Dealer to Pelco for such Products. In no event will Pelco be liable for any special, incidental, or consequential damages (including loss of use, loss of profit, and claims of third parties) however caused, whether by the negligence of Pelco or otherwise.

The above warranty provides the Dealer with specific legal rights. The Dealer may also have additional rights, which are subject to variation from state to state.

- 1. Model and serial number
- 2. Date of shipment, P.O. number, sales order number, or Pelco invoice number
- 3. Details of the defect or problem

If there is a dispute regarding the warranty of a product that does not fall under the warranty conditions stated above, please include a written explanation with the product when returned.

Method of return shipment shall be the same or equal to the method by which the item was received by Pelco.

All merchandise returned for credit may be subject to a 20 percent restocking and refurbishing charge.

Goods returned for repair or credit should be clearly identified with the assigned CA or RA number and freight should be prepaid.
